

Invitation for Bid (IFB-17)

2. Bidding will be conducted through **National Competitive Bidding**, however limited to the bidder who registered within the administrative boundary of the **Northern Province** as per the Public Finance Circular No.04/2016(i) dated 30th September 2016.

To be eligible for contract award, the successful bidder shall not have been blacklisted and as per the Public Finance Circular No: 04/2016(i) dated 30th September 2016, this IFB is limited for the Bidders who have been required valid CIDA registration as mentioned below in the table and possess valid business or company registration within Northern Province.
