**AMENDMENTS TO PROVINCIAL FINANCIAL RULES**

The Hon.Governor, Northern Province has approved the following amendments to the Provincial Financial Rules with effect from **01<sup>st</sup> October 2009**.

**I. Amendment No: 04/2009 - Delegated Authorities to Deal with losses**

Delete PFR No:74.4 and substitute the following rule thereof.

**PFR.74.4** Irrespective of the above provisions, any losses above Rs.1,000,000/= (Rs. One Million) in respect of vehicles, machinery and buildings which have occurred due to security operations against terrorist activities and or any other justifiable reasons that are beyond the control of any officer, the Chief Secretary may authorize write-off after fulfilling all stipulated conditions in the Provincial Financial Rules and subject to the following:

**PFR.74.4.1** On the recommendation by a special Write-off committee consisting of the Chief Secretary (Chairman), Deputy Chief Secretary-Finance (Secretary), other Secretaries and Director, Provincial Audit. **And**

**PFR.74.4.2** After obtaining satisfactory confirmation from the Provincial Treasury that all stipulated procedures and documentation have been complied with. All such Write-offs shall be reported to the Board of Ministers and the Hon. Governor for information.
