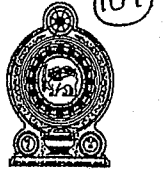

**Salary Advance from Governor's Trust Fund to meet major medical expenses of Northern Provincial Council officers/employees who worked in the districts Kilinochchi, Mullativu and East of Mannar**

On the directive of the Hon.Governor the Governor's Trust Fund will operate a salary advance scheme with effect from 1<sup>st</sup> April 2010 to meet major medical expenses of Northern Provincial Council officers/employees who worked in the districts of Kilinochchi, Mullativu and East of Mannar. The parameters and conditions of this scheme are outlined below.

- This scheme is applicable to confirmed officers/employees of the Northern Provincial Council who worked in the districts of Kilinochchi, Mullativu and East of Mannar to cover major medical expenses during the period 01.01.2009 to 31.12.2011 only.
- The Maximum salary advance payable to an officer/employee under this scheme is Rupees Five hundred thousand (Rs. 500,000) recoverable in sixty installments.
- Eligible expenses will cover :-
  - a) Hospital bills including medicine up to Rs. 400,000.
  - b) Travelling and transport of patient and a by-stander subject to a maximum of Rs. 50,000.
  - c) Subsistence of patient and a by-stander subject to a maximum of Rs. 50,000
  - d) One officer/employee may submit a maximum of two claims during the said period subject to the total amount of Rs. 500,000.
- Normal conditions applicable to loans to public officers will apply.
- The medical treatment should have been obtained from recognized Allopathy medical institutions only.
- Application for salary advance under this scheme to be made on the prescribed form obtainable from the Provincial Treasury.
- The grant of this salary advance will depend on the availability of funds in the Governor's Trust Fund.
