

Invitation for Bid (IFB-06)

DEPARTMENT OF BUILDINGS, NORTHERN PROVINCE.

1. The **Chairman, Department Procurement Committee**, on behalf of the Department of buildings, Northern Province, invites sealed bids from eligible and qualified bidders for the Construction works described in the table below.
 2. Bidding will be conducted through **National Competitive Bidding**, however limited to the bidder who registered within the administrative boundary of the **Northern Province** as per the Public Finance Circular No.04/2016(i) dated 30th September 2016.
 3. To be eligible for contract award, the successful bidder shall not have been blacklisted and as per the Public Finance Circular No: 04/2016(i) dated 30th September 2016, this IFB is limited for the Bidders who have been required valid CIDA registration as mentioned below in the table and possess valid business or company registration within Northern Province.
 4. Qualifications requirements are indicated in section 4 of the Bidding document. Additional details are provided in the **Bidding Data & Contract Data** (Section 5).

Bid number must be written on the left-hand upper corner of envelope. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the Bidder's representatives who choose to attend.
