- 2. This Lease Based Assignment consists of financing, developing, owning, operating, maintaining and removal of solar power electric generation facilities on the rooftop on the schools located in Jaffna, Kilinochchi, Mannar, Mullaithivu & Vavuniya District, Northern Province as further set forth on Section 5 of the Bidding document; obtained under lease basis and sell the solar generated electricity to Ceylon Electricity Board (CEB) through an agreement between Lessee and Ceylon Electricity Board on the basis of Scheme 3 Net Plus, where Ceylon Electricity Board will pay, for the total amount of electricity the Lessee generate as per the terms and conditions under Soorya Bala Sangramaya program and sharing a portion of revenue with the Lessor.
- 3. The Term of this Lease shall be 20 years.
- 4. The minimum anticipated total revenue share for the term shall be 382.75Mn
- 5. Bidding will be conducted through National Competitive Bidding Procedure.
- 6. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have valid registration as Photovoltaic (PV) service provider under Sri Lanka Sustainable Energy Authority.
- 7. Qualifications requirements are indicated in Section 1 and Section 5 of the Bidding document.
