- 4) A bidder can submit bids in respect of one or more vehicles, but for each vehicle separate bidding documents should be used.
- 5) Bidders have to pay a refundable deposit as bid security, by cash at the **Deputy Chief Secretary-Finance, Office of the Deputy Chief Secretary - Finance, Northern Province, Provincial Council Complex, A9 Road Kaithady, Jaffna.** As mentioned in the above table.
