5. General qualification to be fulfilled

5.1 Should have completed active service period of three (03) years in Grade I of the Sri Lanka Animal Production & Health Service and should have been engaged in active service as at the closing date of applications.

5.2 Attention should be given to disciplinary actions in accordance with **Public Administration Circular 30/2019** and the provisions of **Public Service Commission Circular 1/2020**, which have been adopted by the **Northern Provincial Public Service Commission.**

6. Method of Selection

- 6.1 Out of the application received, only the qualified candidates will be called for an interview and officer who has obtained highest marks will be appointed to the relevant post by the Chief Secretary, Northern Province. If the officer concerned is reluctant to accept the said appointment, the officer who has obtained the next highest marks will be appointed to the said post. At the time more than one officer obtain same marks which stands as highest, one person will be selected by the Seniority basis and the final decision relating to recruitment shall be vested in Chief Secretary of Northern Province.
- 6.2 Fields of marks and maximum marks to be given at the structured interview.(Approved marking scheme attached herewith)
- 6.3 The Application prepared as per specimen form annexed herewith should be forwarded along with a file containing the duly certified copies of any other relevant documents.
- 6.4 For attention, the eligible officer selected for the interview is required to make a 10 minutes presentation about **Northern Province current situation** in Animal Production & health. Accordance with the criteria mentioned under section 2.10 of the annexed marking scheme.
