

# INVITATION FOR BIDS (IFB)

1. The Democratic Socialist Republic of Sri Lanka has received a **grant** from the **European Union** towards the cost of **Local Development Support Project**, and intends to apply part of the proceeds of this **grant** to payments under the Contract for Contract for Work as described below.

4. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered in the specialty and grade as stated above with the Construction Industry Development Authority (CIDA).

The method of payment will be **by cash**.

Bids shall be delivered in duplicate to **Chairman, Provincial Project Procurement Committee (PPPC), Local Development Support Project (LDSP), Department of Local Government (NP), Elders' Home Complex, Kaithady** on or before **14.00 Hrs** on **24-Apr-2024**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
