Bid number must be written on the top of the envelop. Late bids will be rejected. Bids will be opened immediately thereafter. Bidders or their authorized representatives may be present at the time of opening bids.
- 10. All bids must be accompanied by a "bid security" which as indicated in the coloum 5. Any bid not accompanied by an acceptable bid security will be rejected.
