  - b. Shall have business registration for supply of Raw foods
  - c. Shall have its registered office or branch in Northern Province
- 3. To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria given in Section 2 -Bidding Data.
- 4. Interested bidders may obtain further information from the above addresses and inspect the bidding documents at the same addresses from 09.00 Hours to 15.00 Hours on working days.

A complete set of Bidding Documents in English language may be purchased from the above addresses (Relevant RDHS Office and Hospitals) by interested bidders on the submission of a written application from 12<sup>th</sup> June 2024 to 02<sup>nd</sup> July 2024 from 09.00 Hours to 15.00 Hours upon of non-refundable cash payment as said above.
- 6. Bids should be submitted to the Provincial Department of Health Services, Northern Province, Health Village, Pannai, Jaffna on or before 10.00 Hours of 3<sup>rd</sup> July 2024. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
