Note: Officers who have obtained computer Driving License awarded by National Apprentice Technical and Training Authority/ a degree in Computer Science recognized by Grants University Commission / Proficiency Level at NVQ 4 or above from an institution approved by the Tertiary Education and Vocational Education Commission shall be exempted from the above computer test.
