

## **NORTHERN PROVINCE**

### **Calling Applications for Post of Provincial Commissioner of Indigenous Medicine in Northern Province.**

Applications are called from qualified officers in Administrative grade I in Sri Lanka Ayurvedic Medical Service for the one vacant Post of Provincial Commissioner of Department of Indigenous Medicine of Northern Province.

**Note: - If qualified applications are not received from the Administrative Grade I of Sri Lanka Ayurvedic Medical Service, Administrative Grade II of Sri Lanka Ayurvedic Medical Service may be considered for the appointment to this post on acting basis. Therefore, Administrative Grade II Sri Lanka Ayurvedic Medical Service officers are also encouraged to apply.**

#### **1. Other Qualifications:-**

Applicants;

- Should be a citizen of Sri Lanka
- Should be of good character
- Should be mentally and physically sound enough to service in this post.
- Should have completed all the qualifications required for the post on or before the closing date.
- Should have not been charged for any disciplinary actions within last five years and should have earned all the salary increments during this period.
- Shall have completed an active satisfactory service for a period of five years immediately preceding date of the closing.

#### **2. Method of Selection:**

Officers who have completed the aforementioned qualification shall be subjected to an interview lead by a board of interview approved by the Hon. Governor and marks shall be offered according to a marking scheme.

The decision of the Honorable Governor shall be final regarding this appointment.

### 3. Conditions of the Employment and Service.

- This appointment shall be subjected to general rules set out in the Procedural of the Public Service Commission, Establishment Code, Financial Regulations and the relevant service minute and the conditions mentioned in the letter of appointment issued at the time of appointment to the relevant post shall be subjected to regulations of the Provincial Council / Statutes/ Financial Regulations issued by the Honorable Governor from time to time
- Selected candidates should be agreeable to serve in the Northern Provincial Council for a period of 03 years.

### 4. Submission of Application:

Officers who have completed the aforesaid qualifications should prepare an application complying with the specimen in annexure I (Can be downloaded from the website [www.np.gov.lk](http://www.np.gov.lk)) and duly completed an application should be sent to the below mentioned address by Registered Post on or before **26.07.2021**

The candidature will be revoked if any detail in the application was found false or incorrect before the appointment.  
If such information is revealed after the appointment he/ she will be dismissed after taking appropriate actions.
