

Your reference is drawn to Provincial Financial Regulation 365 - 382 and Provincial Finance Circular No - PF/AP/01/2021 dated 06.10.2021 on the above subject.

1. Accordingly, please take necessary steps to complete verification of stores for your Ministries / Departments by appointing Committee on or before 15th of December 2024, Board of Survey report and its follow up action report should be rendered to Auditor General (Categories - I & II) with the copy to Deputy Chief Secretary - Finance (Category - I only) and the Department which has Regional Offices - Category II should send the annexed specimen format (Annexure - 01) to Deputy Chief Secretary - Finance, as follows.

- On or before 31st May 2025
- 2. When the committee appointed for the board of survey for the respective Ministry / Department or Regional Office comes under the Department, it should be ensured at least one member to be appointed from the out of the Ministry / Department or Regional Office.
