2. **The Chairman, Local Authority Procurement Committee** on behalf of the **Nallur Pradeshiya Sabha** now invites sealed bids from eligible and qualified bidders for the **goods** stated in the Table below.
3. Bidding will be conducted through National Competitive Bidding procedure.
4. Interested eligible bidders may obtain further information from **Secretary, Nallur Pradeshiya Sabha, 14/5 Karuvappulam Road, Kokkuvil (T.P No: 0212222700, Fax No: 0212220138)** and inspect the bidding documents at **Nallur Pradeshiya Sabha, 14/5 Karuvappulam Road, Kokkuvil** from **6-Feb-2024 until 3-March-2024** between **09:00 AM to 02:00 PM** on public working days.
5. Qualification requirements include: **to qualify for contract award are included in Section II (Bidding Data Sheet) and Section III (Evaluation and Qualification Criteria) in the Bidding Document. Additional details are provided in the Bidding Documents.**

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the address "**Secretary, Nallur Pradeshiya Sabha, 14/5 Karuvappulam Road, Kokkuvil**" on Public Working Days between **09:00 AM to 02:00 PM** from **6-Feb-2024 until 3-March-2024** and upon payment of a non-refundable fee stated in the Table below. The method of payment will be **Cash or Card.**
7. Bids must be delivered to **The Chairman, Local Authority Procurement Committee, Nallur Pradeshiya Sabha 14/5 Karuvappulam Road, Kokkuvil** on or before **4-March-2024 at 10.00AM**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders or their representatives who choose to attend in person. All bids must be accompanied by a Bid-Security and the validity periods of bid security as given below.
8. The complete bid should be forward in two copies as original and duplicate. The Original and Duplicate should be enclosed separately and mark original and duplicate respectively in sealed envelopes. Both envelopes should be marked the "**Bid Number**" on top left-hand corner of the envelop.
9. The pre bid meeting will be held at **Nallur Pradeshiya Sabha** on **19-Feb-2024 at 10.00AM**. Interested Bidders may participate in this meeting their own expenses.
